Rules of Play for 50/50 & Prize Electronic Raffle:

1. The lottery will only take place online at www.veteranshouse.rafflenexus.com from January 20, 2024 – February 8, 2024.

2. All tickets will only be sold to people who are 18 years of age or older.
3. Must be in the province of Ontario at the time of purchase.
4. Tickets are:

1-Ticket for \$5; 3-Ticket Pack for \$10; 7-Ticket Pack for \$20; 25-Ticket Pack for \$50; 75-Ticket Pack for \$100
5. Tickets are available online at www.veteranshouse.rafflenexus.com.
6. Tickets will be sold using an electronic raffle system supplied by Raffle Nexus.
7. After buying, patrons will receive a confirmation e-mailed with their 50/50 registered number from a Random Selection System. No specific numbers can be given as numbers are generated randomly.
8. The winning ticket number will be selected by a Random Number Generation (RNG) system from all raffle numbers sold for the draw.
9. The amount of the 50/50 will be visible at www.veteranshouse.rafflenexus.com.
10. The winning numbers will be announced via live stream on The Disability Channel.
11. The winner may claim their prize by contacting Veteran House Inc. / Maison Des Veterans Inc. at: (613) 328-8536, or by email at: info@veteranshouse.ca. The winner will then be paid by cheque for the amount posted at the event for which they bought their ticket. The cheque will be made out to the name on file at time of purchase. **All payments will be made by cheque.** The cheque will be shipped via Canada Post Registered Mail to the address on file at time of purchase.
12. The winning ticket holder has **6 months** in which to claim their prize from the date of the draw their ticket was purchased for.
13. The winner must provide their name, address, and phone number with picture identification for our report sheet.

14. Once the certified winner is verified, and provides identification with photo ID, they will be given a cheque in the amount of the declared prize which is, at minimum, 50% of the total sales for that draw. If the winner cannot provide photo ID, then the winning proceeds will be held until such identification can be provided.
15. In the event no winner comes forward, the winning stub will be retained digitally and held for 6 months. After that time period has elapsed the prize will be donated to a charity other than Veteran House Inc. / Maison Des Veterans Inc., with the approval of the Alcohol and Gaming Commission of Ontario (AGCO).
16. The following individuals are not eligible to participate in the 50/50 draws:
 - i. Veteran House Inc. / Maison Des Veterans Inc. Staff and Board of Directors, their spouses, or any individual who resides in the same residence as the aforementioned persons are not permitted to purchase tickets and are not eligible to win.
 - ii. No person assisting in the conduct and management of a lottery event may have any monetary interest in any card, ticket or bet, or have a chance to win a lottery prize in any way.
 - iii. No designated member responsible for the conduct of the licensed lottery, or volunteers assisting with the lottery, may have any direct or indirect personal financial interest in the funds raised.
